Strategy Highlights

River Road's International Equity ADR (iADR) Strategy seeks to provide long-term capital appreciation by investing primarily in non-U.S. companies trading as ADRs or otherwise traded in the United States.

The Strategy seeks to invest in high quality companies with improving fundamentals, trading at attractive valuations. Typical investment criteria include a minimum market capitalization of \$3 B and average daily liquidity of \$5 MM (including both ADR and local market liquidity).

The stock selection process is complemented by a risk averse approach that employs balanced diversification and a structured sell discipline.

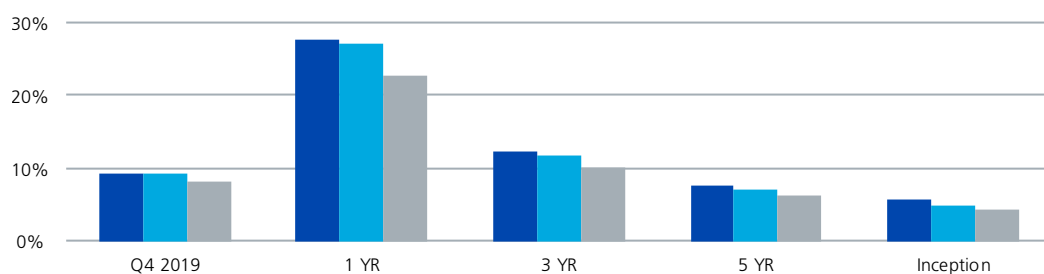

Portfolio Review

Global equity markets soared in Q4, supported by progress on trade, greater clarity around Brexit, and an improved outlook for 2020 earnings. The **MSCI EM index (+11.93%) led the outperformance while the MSCI EAFE and S&P 500 returned +8.21% and +9.07%**, respectively, in the quarter.

From a regional perspective, **Asia-Pacific (ex Japan) (+65 bps)** and **Europe (ex UK) (+53 bps)** were among the top contributors to relative return for Q4. Outperformance was partially offset by **North America (-23 bps)** and the **Middle East (-15 bps)**.

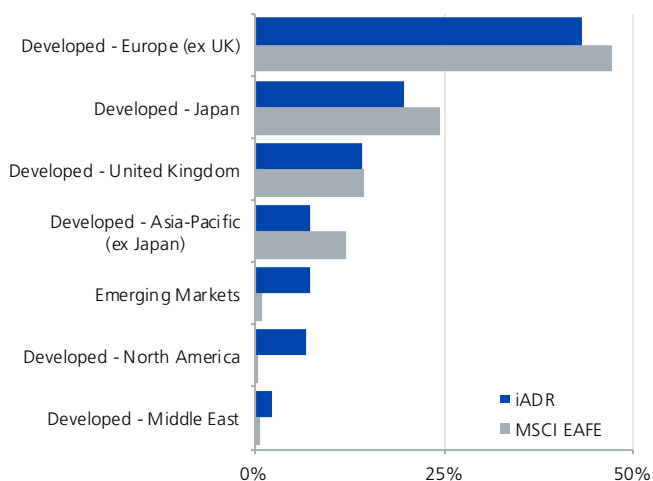
From a sector perspective, **Information Technology (+75 bps)** and **Industrials (+24 bps)** were the largest contributors to relative performance for Q4. Outperformance was partially offset by **Materials (-28 bps)** and **Real Estate (-10 bps)**.

The top contributor in Q4 was **STMicroelectronics NV ADR RegS (STM)**, a global semiconductor manufacturer. STM delivered mixed results during the quarter with two out of three segments reporting year-over-year revenue declines and consolidated revenue increasing only +1.2%. However, consolidated revenue increased +17.5% sequentially owing to end market recovery in Asia and, to a lesser degree, in the Americas (Europe was weak). Our outlook is unchanged as we expect STM to **continue to take share** from Texas Instrument (TXN) in the analog market and **dominate the nascent silicon carbide market while delivering improved operating margins and free cash flow generation from meaningful operational improvements**.

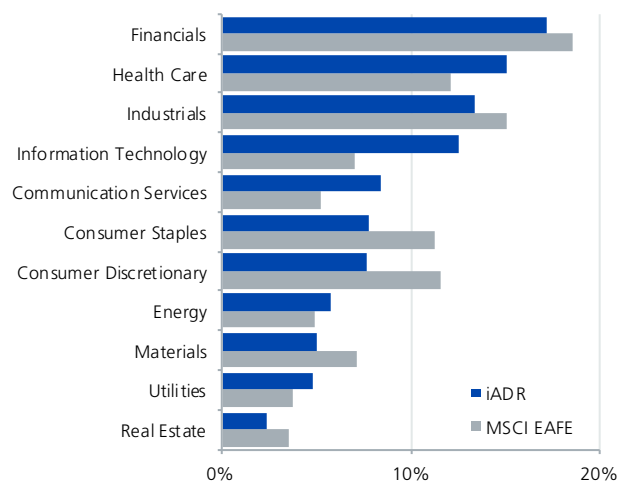
The bottom contributor during the quarter was **Danone SA ADR (DANOY)**, a leading global manufacturer of fresh dairy products, water, and nutrition products with a 100-year heritage and deep expertise in health and nutrition. Weak volume growth for its water business and lower-than-expected yogurt sales in the U.S. offset strong pricing momentum for the Nutrition business. DANOY lowered its full year guidance, and the stock lost more than 7% with the Q3 earnings release. **We expect the water business to rebound in Q4 and are encouraged by strong demand for the company's nutrition products**.

Upside for international stocks could be limited as high valuations are weighed against an improving earnings outlook and accommodative monetary and fiscal policies.
