Strategy Summary

River Road's Small-Mid Cap Value (SMID) Strategy utilizes a fundamentally driven research process to identify attractive purchase candidates from a universe of small to mid cap stocks. The Strategy seeks to invest in well-managed, financially strong companies that are trading at meaningful discounts to our assessed valuations. We further target companies with predictable and sustainable business models that are undiscovered or underfollowed by traditional Wall Street research firms. Our stock selection process is complemented by a risk averse approach that employs both balanced diversification and a structured sell discipline.

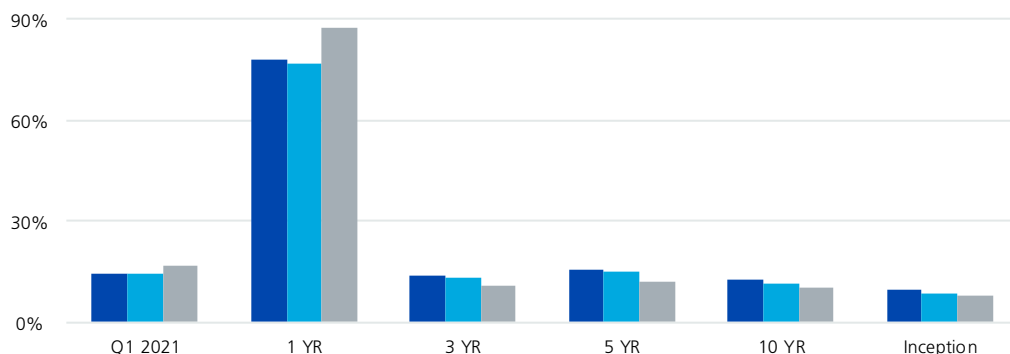

Market Highlights

- Stocks delivered robust returns in Q1, capping a historic 12-month recovery.**
- Small cap and value delivered one of their best relative performances in decades.
- Within the Russell 2500 Value index, **Energy (+38.08%)** and **Consumer Discretionary (+26.02%)** posted the highest total returns, while **Utilities (+3.82%)** and **Health Care (+6.49%)** posted the lowest.
- It was a disappointing quarter for active small cap value managers** with just **36%** beating the index. However, following a very difficult January, performance significantly improved as the quarter progressed.

Portfolio Highlights

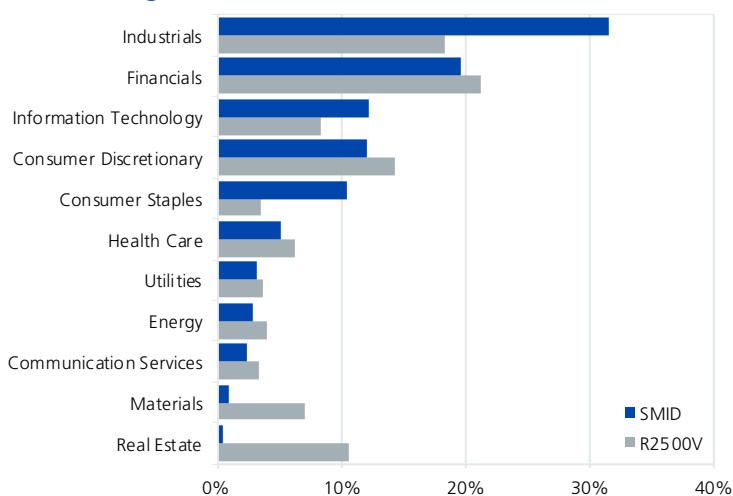
- For Q1, the Small-Mid Cap Value (SMID) Composite returned **+14.38%** (+14.23% net) versus **+16.83%** for the Russell 2500 Value benchmark.
- The sectors with the highest contribution to relative return in Q1 were **Real Estate (+73 bps)** and **Information Technology (+59 bps)**.
- The holdings with the highest contribution to Portfolio return were **Atkore Inc. (ATKR, +118 bps)** and **Avaya Holdings Corp. (AVYA, +112 bps)**.
- The sectors with the lowest contribution to relative return in Q1 were **Financials (-285 bps)** and **Consumer Discretionary (-58 bps)**.
- The holdings with the lowest contribution to Portfolio return were **Cannae Holdings Inc. (CNNE, -49 bps)** and **Air Transport Services Group Inc. (ATSG, -35 bps)**.

Outlook

- Absolute valuations are alarmingly high and investor sentiment is euphoric, but the recovery shows few, if any, signs of retreating.** From a relative perspective, **small cap still looks attractive versus large cap** and **value remains 'dirt cheap' compared to growth.**

The Small-Mid Cap Value Composite contains fully discretionary small-mid cap value equity accounts that seek capital appreciation by investing primarily in small-mid cap value domestic equity securities that trade at a discount to our valuation as determined using RRAM's proprietary Absolute Value® approach. For this Composite, RRAM defines a small to mid cap company as one whose market capitalization is less than \$10 B. RRAM selects securities from a universe of companies with a market capitalization at the time of initial purchase typically between \$250 MM and \$10 B, employing a value driven, bottom-up fundamental approach. The official benchmark for the Composite is the Russell 2500 Value index. All other indices are shown for additional information only. The U.S. dollar is the currency used to express performance and includes the reinvestment of income. Composite performance is presented gross of foreign withholding taxes on dividends, interest income, and capital gains. All Composite performance is after the deduction of trading costs.
