## Investment Objective

Long-term total return = Russell 3000 Value index plus a minimum of +200 bps

## Strategy Summary

**Focused Absolute Value® II (FAV II) is a concentrated, all cap value strategy comprised of what the analyst team believes are the 'best and most timely ideas' selected from the stocks held across all River Road U.S. equity strategies.**<sup>1</sup>

The FAV II Strategy leverages the existing Focused Absolute Value® (FAV) Strategy's portfolio design and investment process, and typically invests in companies with a market cap of \$1 B or greater at the time of initial purchase (versus \$250 MM for the FAV Strategy).

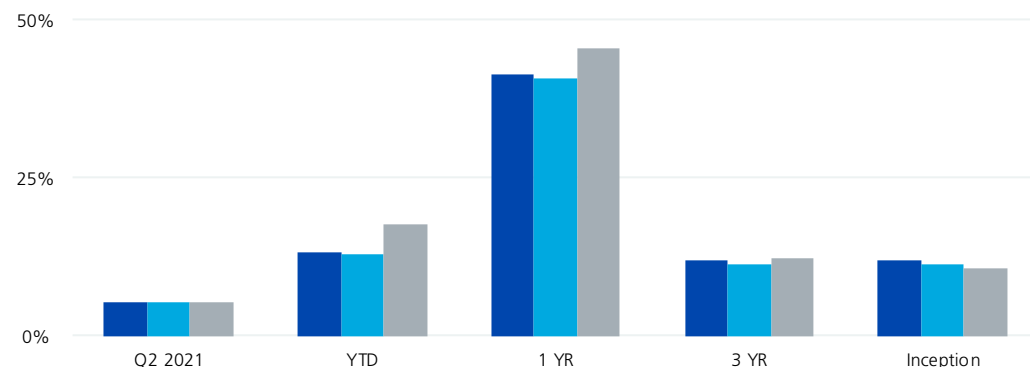

## Market Highlights

- **Stocks continued to soar in Q2 amidst a broad rally for risk assets.**
- Large caps led small caps for the quarter, while style performance was mixed across market caps.
- The Russell 1000 returned **+8.54%** for Q2 versus **+4.29%** for the Russell 2000 and **+8.24%** for the Russell 3000; the Russell 3000 Value returned **+5.16%** versus **+11.38%** for the Russell 3000 Growth.
- Within the Russell 3000 Value index, **Energy (+12.34%)** and **Real Estate (+10.55%)** posted the highest total returns, while **Utilities (-0.49%)** and **Information Technology (+1.21%)** posted the lowest.

## Portfolio Highlights

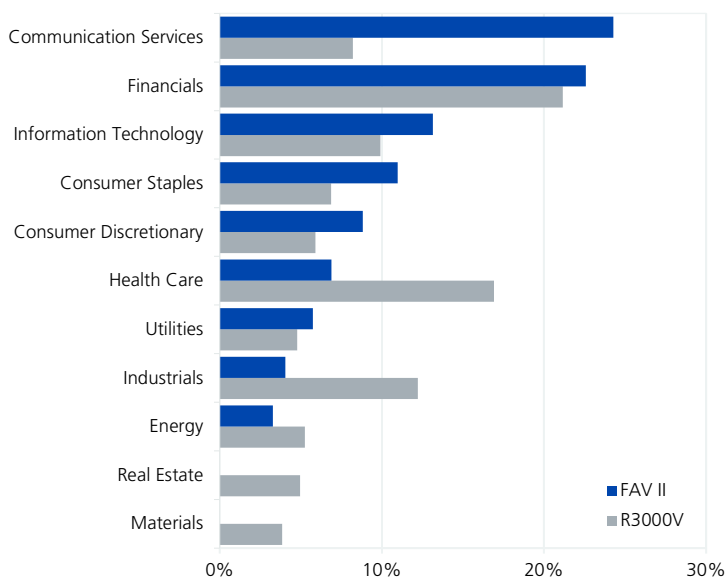
- The River Road Focused Absolute Value® II (FAV II) Composite returned **+5.32%** (+5.20% net) for Q2 versus **+5.16%** for the Russell 3000 Value benchmark. Year to date, the Composite returned **+13.10%** (+12.87% net) versus **+17.67%** for the benchmark.
- The holdings with the highest contribution to Portfolio return were **Liberty Broadband Corp. (CI C) (LBRDK)** and **Berkshire Hathaway Inc. (CI B) (BRK.B)**.
- The holdings with the lowest contribution to Portfolio return were **Cannae Holdings Inc. (CNNE)** and **Air Transport Services Group Inc. (ATSG)**.

## Outlook

- **U.S. stocks are expensive, but high prices rarely kill a bull market** – especially when earnings growth is robust and interest rates are extremely low.
