## Strategy Summary

River Road's Small Cap Value (SCV) Strategy utilizes a fundamentally driven research process to identify attractive purchase candidates from a universe of smaller cap stocks. The Strategy seeks to invest in well-managed, financially strong companies that are trading at meaningful discounts to our assessed valuations. We further target companies with predictable and sustainable business models that are undiscovered or underfollowed by traditional Wall Street research firms. Our stock selection process is complemented by a risk averse approach that employs both balanced diversification and a structured sell discipline.



## Market Highlights

- Stocks continued to soar in Q2 amidst a broad rally for risk assets.
- Large caps led small caps for the quarter, while style performance was mixed across market caps.
- Within the Russell 2000 Value index, **Communication Services (+53.24%)** and **Energy (+20.04%)** posted the highest total returns, while **Consumer Staples (-2.57%)** and **Utilities (-2.29%)** posted the lowest.
- A challenging June weighed on the results of active small cap value managers with just **46% beating the index for the quarter**.

## Portfolio Highlights


- For Q2, the River Road Small Cap Value (SCV) Composite returned **+2.96%** (+2.75% net) versus **+4.56%** for the Russell 2000 Value benchmark. Year to date, the Composite returned **+16.71%** (+16.25% net) versus **+26.69%** for the benchmark.
- The sectors with the highest contribution to relative return in Q2 were **Consumer Staples** and **Health Care**.
- The holdings with the highest contribution to Portfolio return were **ORBCOMM Inc. (ORBC)** and **NCR Corp. (NCR)**.
- The sectors with the lowest contribution to relative return in Q2 were **Energy** and **Communication Services**.
- The holdings with the lowest contribution to Portfolio return were **Air Transport Services Group Inc. (ATSG)** and **Cannae Holdings Inc. (CNNE)**.

## Outlook

- U.S. stocks are expensive, but high prices rarely kill a bull market** – especially when earnings growth is robust and interest rates are extremely low. **Further, from a relative perspective, we believe high quality small cap value stocks remain exceptionally well positioned.**

For this Composite, RRAM defines a small cap company as one whose market capitalization is less than \$4 B. RRAM selects securities from a universe of companies with a market capitalization at the time of initial purchase typically between \$150 MM and \$4 B, employing a value-driven, bottom-up fundamental approach. The official benchmarks for the Composite are the Russell 2000 Value and the Russell 2000 indices. All other indices are shown for additional information only. The U.S. dollar is the currency used to express performance and includes the reinvestment of income. Composite performance is presented gross of foreign withholding taxes on dividends, interest income, and capital gains. All Composite performance is after the deduction of trading costs. Net of fee performance is calculated using actual management fees, which includes performance fees for some periods.
