Investment Objectives

- Long-term total return > Russell 3000 Value index plus 200 to 400 bps
- Target yield \geq 150% of the Russell 3000 Value index
- Target volatility < Russell 3000 Value

Strategy Summary

River Road's Dividend All-Cap Value (DAV) Strategy utilizes a fundamentally driven research process to identify attractive purchase candidates from an all cap universe of equity securities with attractive dividend yields. The Strategy seeks to invest in well-managed, financially strong companies with high and growing dividends, targeting companies that are also trading at meaningful discounts to our assessed valuations. Typical investment criteria include:

- Minimum market cap of \$300 MM at the time of initial purchase
- Indicated dividend yield > 0%; prefer > 2%

The stock selection process is complemented by a risk averse approach that employs balanced diversification and a structured sell discipline.



Market Highlights

- Inflation accelerated to the **highest rate since the early 1980s** and bond investors got pummeled by rising long-term interest rates.
- The Russia-Ukrainian war sparked another **surge in inflation** and prompted questions about the **sustainability of globalization**.
- Large cap and value led in Q1**, as leadership shifted to **higher beta, lower quality stocks; dividend stocks continued to outperform** despite the rise in interest rates.

Portfolio Highlights


- The Dividend All-Cap Value (DAV) Composite returned **+1.62%** (+1.51% net) for Q1 versus **-0.85%** for the Russell 3000 Value.
- At the end of Q1, the dividend yield of the Portfolio was **3.04%**, which is **156% of the 1.95% yield of the Russell 3000 Value** and **more than double the 1.39% yield of the S&P 500**.
- The Portfolio benefited from positive factor tailwinds in the quarter, particularly the very strong performing dividend yield factor, and the structural **overweight to higher yielding stocks was a boon to relative results**.
- The sectors with the highest contribution to relative return in Q1 were **Industrials** and **Financials**.
- The holdings with the highest contribution to active return were **Marathon Petroleum Corp. (MPC)** and **Williams Companies Inc. (WMB)**.
- The sectors with the lowest contribution to relative return in Q1 were **Consumer Staples** and **Materials**.
- The holdings with the lowest contribution to active return were **Unilever PLC Sponsored ADR (UL)** and **Magna International Inc. (MGA)**.

Outlook

- The events of Q1 have only reinforced our expectations that **2022 would prove to be volatile for U.S. equity markets as stimulus is rapidly eliminated, and the economy will likely have to absorb higher financing costs, higher input prices, and now war on Europe's doorstep**. Given the mounting headwinds, we believe it is an increasing concern that economic stability/growth could take a downward swing before the Fed is successful in its effort to tame inflation.
