Investment Objective

Long-term total return = Russell 3000 Value index plus a minimum of +200 bps

Strategy Summary

Focused Absolute Value® (FAV) is a concentrated, all cap value strategy comprised of what the firm's associate portfolio managers and analysts believe are the 'best and most timely ideas' selected from the stocks held across all River Road U.S. equity strategies.¹

The Strategy combines the firm's proven investment processes with the stock picking skills of River Road portfolio managers and collective insights and opinions of the firm's associate portfolio managers and analysts.

The Strategy seeks to remain fully invested at all times, is index independent, and is highly opportunistic. The minimum market cap for investment is \$250 MM (at the time of initial purchase).

¹If a holding is liquidated from all RRAM portfolios, the stock must be sold from the Focused Absolute Value® Portfolio within a reasonable period of time (typically less than 30 days).

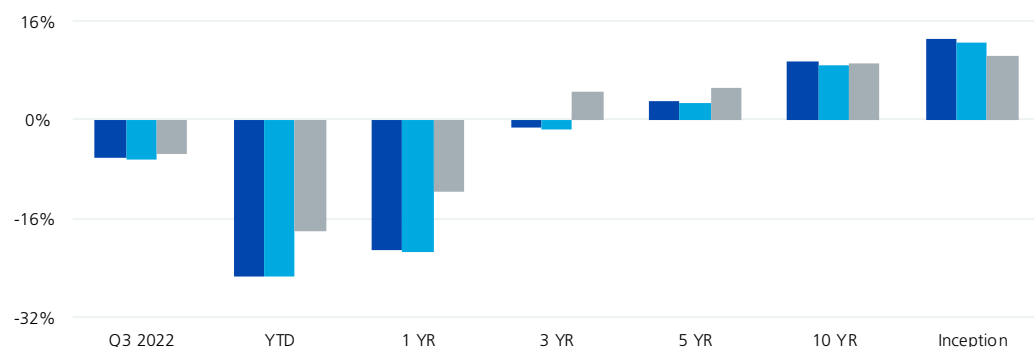

Market Highlights

- Stocks rallied early in the quarter but plunged back into bear market territory as inflation remained hot and the Fed reaffirmed its commitment to conquering it.
- Small caps outperformed large caps and growth outperformed value across the market cap spectrum.
- The Russell 2000 index returned **-2.19%** for Q3 versus **-4.61%** for the Russell 1000 and **-4.46%** for the Russell 3000. The Russell 3000 Value returned **-5.56%** versus **-3.37%** for the Russell 3000 Growth.
- Within the Russell 3000 Value index, **Energy (+3.23%)** and **Consumer Discretionary (-2.98%)** posted the highest total returns, while **Communication Services (-13.41%)** and **Real Estate (-10.63%)** posted the lowest.

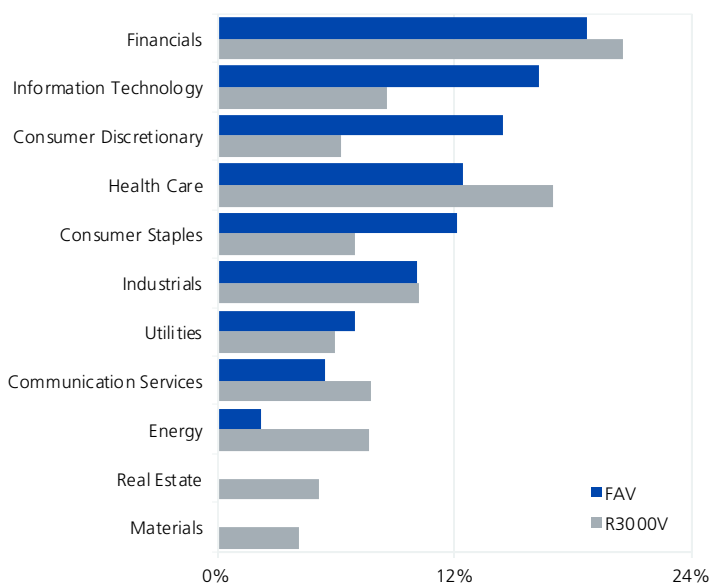
Portfolio Highlights

- The River Road Focused Absolute Value® (FAV) Composite returned -6.34% (-6.41% net) for Q3 versus -5.56% for the Russell 3000 Value benchmark. Year to date, the Composite returned -25.32% (-25.48% net) versus -17.97% for the benchmark.
- The holdings with the highest contribution to active return were **Starbucks Corp. (SBUX)** and **AES Corp. (AES)**.
- The holdings with the lowest contribution to active return were **Comcast Corp. (CI A)** (**CMCSA**) and **ACI Worldwide Inc. (ACIW)**.

Outlook

- Little has changed in our outlook – we continue to expect further downside for stocks.**
