Strategy Summary

River Road's Small Cap Value (SCV) Strategy utilizes a fundamentally driven research process to identify attractive purchase candidates from a universe of smaller cap stocks. The Strategy seeks to invest in well-managed, financially strong companies that are trading at meaningful discounts to our assessed valuations. We further target companies with predictable and sustainable business models that are undiscovered or underfollowed by traditional Wall Street research firms. Our stock selection process is complemented by a risk averse approach that employs both balanced diversification and a structured sell discipline.

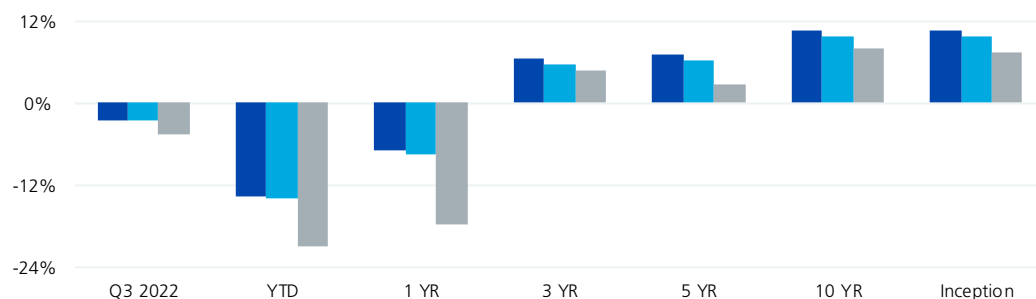

Market Highlights

- Stocks rallied early in the quarter but plunged back into bear market territory as inflation remained hot and the Fed reaffirmed its commitment to conquering it.
- Small caps outperformed large caps and growth outperformed value across the market cap spectrum.
- Within the Russell 2000 Value, **Energy (+7.84%)** and **Health Care (+3.16%)** had the highest total returns, while **Communication Services (-15.24%)** and **Real Estate (-11.37%)** had the lowest.
- It was a challenging quarter for active small cap value managers with just **45%** beating the benchmark according to Jefferies.

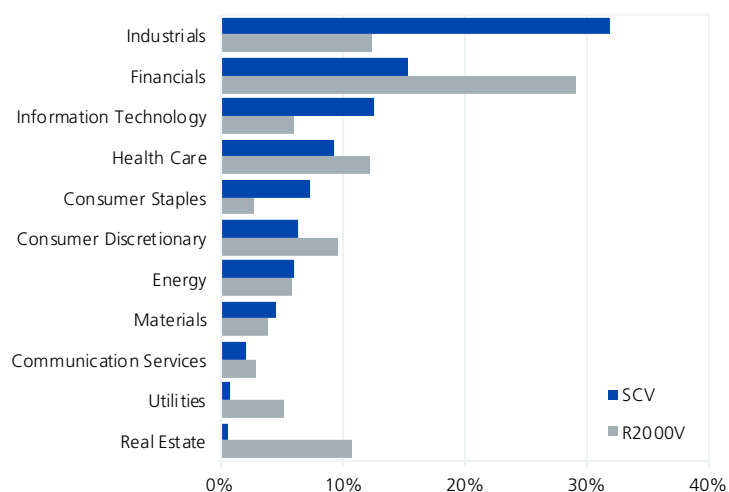
Portfolio Highlights

- For Q3, the River Road Small Cap Value (SCV) Composite returned -2.48% (-2.62% net) versus -4.61% for the Russell 2000 Value benchmark. Year to date, the Composite returned -13.54% (-13.92% net) versus -21.12% for the benchmark.
- The sectors with the highest contribution to relative return (total effect) in Q3 were **Consumer Staples (+92 bps)** and **Real Estate (+72 bps)**.
- The holdings with the highest contribution to active return were **Computer Services Inc. (CSVI)** and **BJ's Wholesale Club Holdings Inc. (BJ)**.
- The sectors with the lowest contribution to relative return in Q3 were **Health Care (-142 bps)** and **Information Technology (-63 bps)**.
- The holdings with the lowest contribution to active return were **NCR Corp. (NCR)** and **Air Transport Services Group Inc. (ATSG)**.

Outlook

- Little has changed in our outlook – we continue to expect further downside for stocks.

The Small Cap Value Composite contains fully discretionary small cap value equity accounts that seek capital appreciation by investing primarily in small cap value domestic equity securities that trade at a discount to our valuation as determined using RRAM's proprietary Absolute Value® approach. For this Composite, RRAM defines a small cap company as one whose market capitalization is less than \$4 B. RRAM selects securities from a universe of companies with a market capitalization at the time of initial purchase typically between \$150 MM and \$4 B, employing a value-driven, bottom-up fundamental approach. The official benchmarks for the Composite are the Russell 2000 Value and the Russell 2000 indices. All other indices are shown for additional information only. Composite performance may differ materially from the indices as the Composite only invests in a subset of the securities contained in the indices and also invests in securities not contained in the indices. The U.S. dollar is the currency used to express performance and includes the reinvestment of income.
