River Road's Small-Mid Cap Value II (SMID II) Strategy focuses on companies between \$500 MM and \$10 B in market cap. The SMID II Strategy employs the same bottom-up, fundamentally driven investment process as the firm's Small Cap Value and Small-Mid Cap Value Strategies.

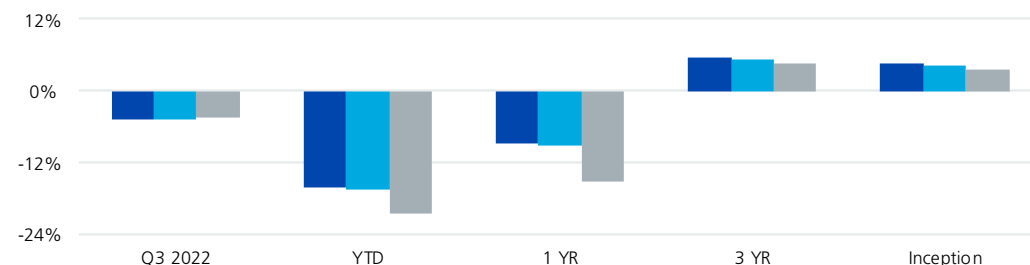

Market Highlights

- Stocks rallied early in the quarter but plunged back into bear market territory as inflation remained hot and the Fed reaffirmed its commitment to conquering it.
- Small caps outperformed large caps and growth outperformed value across the market cap spectrum.
- Within the Russell 2500 Value, **Energy (+7.69%)** and **Industrials (-1.90%)** had the highest total returns, while **Communication Services (-9.94%)** and **Real Estate (-9.75%)** had the lowest.
- It was a challenging quarter for active small cap value managers with just **45%** beating the benchmark according to Jefferies.

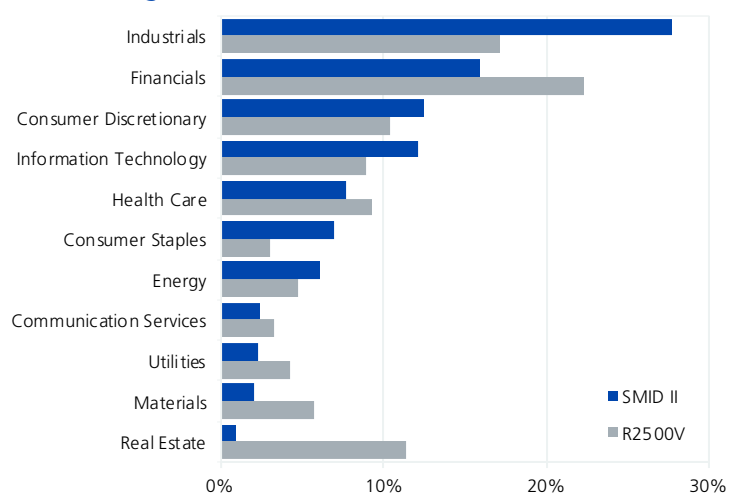
Portfolio Highlights

- For Q3, the River Road Small-Mid Cap Value II (SMID II) Composite returned -4.68% (-4.78% net) versus -4.50% for the Russell 2500 Value benchmark. Year to date, the Composite returned -16.31% (-16.56% net) versus -20.41% for the benchmark.
- The sectors with the highest contribution to relative return (total effect) in Q3 were **Consumer Discretionary (+74 bps)** and **Consumer Staples (+70 bps)**.
- The holdings with the highest contribution to active return were **BJ's Wholesale Club Holdings Inc. (BJ)** and **Comfort Systems USA Inc. (FIX)**.
- The sectors with the lowest contribution to relative return in Q3 were **Information Technology (-258 bps)** and **Industrials (-68 bps)**.
- The holdings with the lowest contribution to active return were **NCR Corp. (NCR)** and **Air Transport Services Group Inc. (ATSG)**.

Outlook

- Little has changed in our outlook – we continue to expect further downside for stocks.

The Small-Mid Cap Value II Composite contains fully discretionary small-mid cap value equity accounts that seek capital appreciation by investing primarily in small-mid cap value domestic equity securities that trade at a discount to our valuation as determined using RRAM's proprietary Absolute Value® approach. For this Composite, RRAM defines a small to mid cap company as one whose market capitalization is less than \$10 B. RRAM selects securities from a universe of companies with a market capitalization at the time of initial purchase typically between \$500 MM and \$10 B, employing a value driven, bottom-up fundamental approach. The official benchmark for the Composite is the Russell 2500 Value index. All other indices are shown for additional information only.
