Investment Objective

Long-term total return = Russell 3000 Value index plus a minimum of +200 bps

Strategy Summary

Focused Absolute Value® II (FAV II) is a concentrated, all cap value strategy comprised of what the firm's associate portfolio managers and analysts believe are the 'best and most timely ideas' selected from the stocks held across all River Road U.S. equity strategies.¹

The FAV II Strategy leverages the existing Focused Absolute Value® (FAV) Strategy's portfolio design and investment process and typically invests in companies with a market cap of \$1 B or greater at the time of initial purchase (versus \$250 MM for the FAV Strategy).

¹If a holding is liquidated from all RRAM portfolios, the stock must be sold from the Focused Absolute Value® II Portfolio within a reasonable period of time (typically less than 30 days).

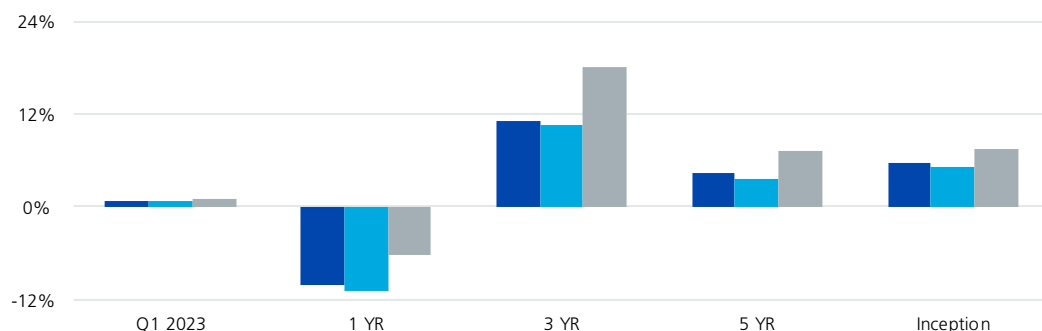

Market Highlights

- **Stocks delivered positive results in Q1 despite a slew of negative events**, including two of the largest bank failures in history.
- A sharp style reversal in March resulted in **large cap and growth significantly outperforming small cap and value**.
- Within the Russell 3000 Value index, **Communication Services (+19.44%)** and **Information Technology (+14.19%)** posted the highest total returns, while **Financials (-6.05%)** and **Health Care (-5.54%)** posted the lowest.

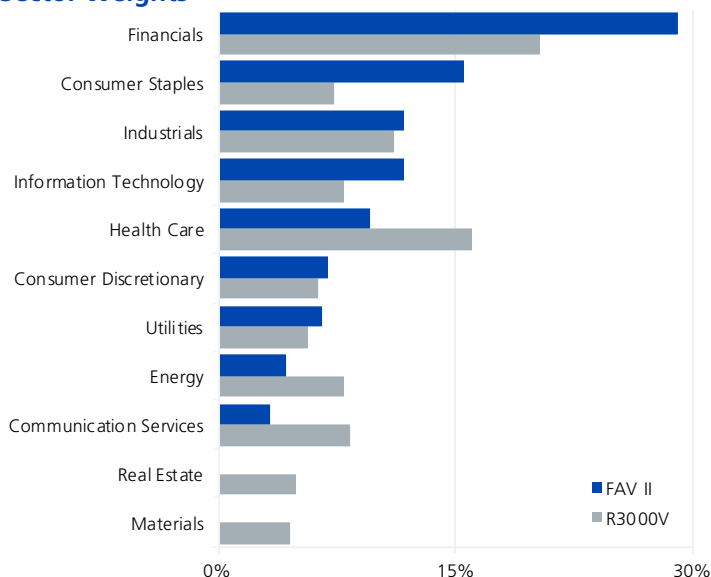
Portfolio Highlights

- The River Road Focused Absolute Value® II (FAV II) Composite returned **+0.78%** (**+0.60%** net) for Q1 versus **+0.91%** for the Russell 3000 Value.
- The holdings with the highest contribution to active return were **Fairfax Financial Holdings Ltd. (FRFHF: +14%, +71 bps)** and **Asbury Automotive Group Inc. (ABG: +36%, +60 bps)**.
- The holdings with the lowest contribution to active return were **Pfizer Inc. (PFE: -20%, -91 bps)** and **AES Corp. (AES: -16%, -69 bps)**.

Outlook

- **The bear market is NOT over.** We believe the regional banking crisis marks the middle phase in the downturn and a string of bad events, a recession, or a deeper trough in earnings will signal the ultimate bottom in stocks.

Representative Portfolios: Unless otherwise noted, information is based on a representative portfolio. Top and bottom contributors are calculated gross of fees for the most recent quarter and based on portfolio contribution to active return, which is calculated as the portfolio-weighted return relative to the overall index. For the purpose of assessing top and bottom contributors, the contribution of child securities is aggregated with that of the parent for corporate actions that occurred during the most recent calendar quarter. The performance numbers included in parentheses behind a stock's name refer to that stock's total gross return (dividends reinvested) and contribution to active return for the representative portfolio during the period.
