Investment Objective

Long-term total return = Russell 3000 Value index plus a minimum of +200 bps

Strategy Summary

Focused Absolute Value® (FAV) is a concentrated, all cap value strategy comprised of what the firm's associate portfolio managers and analysts believe are the 'best and most timely ideas' selected from the stocks held across all River Road U.S. equity strategies.¹

The strategy combines the firm's proven investment processes with the stock picking skills of River Road portfolio managers and collective insights and opinions of the firm's associate portfolio managers and analysts.

The strategy seeks to remain fully invested at all times, is index independent, and is highly opportunistic. The minimum market cap for investment is \$250 MM (at the time of initial purchase).

¹If a holding is liquidated from all RRAM portfolios, the stock must be sold from the Focused Absolute Value® portfolio within a reasonable period of time (typically less than 30 days).

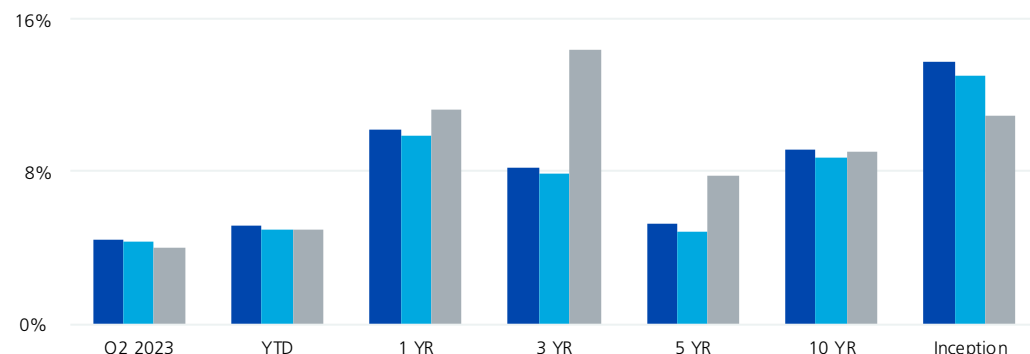

Market Highlights

- Stocks continued to advance amidst a sharply bifurcated market.
- Large cap and growth outperformed small cap and value, but at a slower pace than Q1.
- Within the Russell 3000 Value index, **Communication Services (+10.97%)** and **Industrials (+9.05%)** posted the highest total returns, while **Utilities (-2.79%)** and **Energy (-0.66%)** posted the lowest.

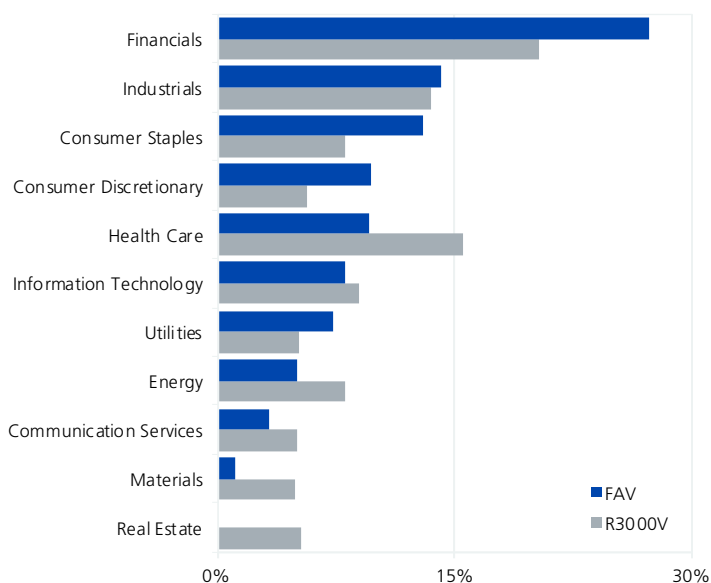
Portfolio Highlights

- The River Road Focused Absolute Value® (FAV) composite returned **+4.40%** (**+4.32%** net) for Q2 versus **+4.03%** for the Russell 3000 Value benchmark. Year to date, the composite returned **+5.15%** (**+4.99%** net) versus **+4.98%** for the benchmark.
- The holdings with the highest contribution to active return were **Patterson Companies Inc. (PCO: +30%, +75 bps)** and **Molson Coors Beverage Co. (CI B) (TAP: +27%, +74 bps)**.
- The holdings with the lowest contribution to active return were **BJ's Wholesale Club Holdings Inc. (BJ: -16%, -67 bps)** and **AES Corp. (AES: -13%, -65 bps)**.

Outlook

- A mild to moderate recession remains base case, but we believe FAV is positioned for a range of scenarios.
- Normalization to a real yield regime is underway, which we believe will promote healthy price discovery and value leadership.**

For the purpose of assessing top and bottom contributors, the contribution of child securities is aggregated with that of the parent for corporate actions that occurred during the most recent calendar quarter. The performance numbers included in parentheses behind a stock's name refer to that stock's total gross return (dividends reinvested) and contribution to active return for the representative portfolio during the period.
